

GCU Board of Directors Vacancy Information

Board of Directors Authority

The GCU's Board of Directors is seeking qualified candidates to fill two Board Member vacancies due to the retirement of GCU Directors Dorothy Foran and Barbara Kushner. The Board of Directors has the authority to fill Board vacancies per Paragraph 51 of the Bylaws:

Par. 51: The Directors shall have the authority to fill a vacancy of an elected Director for the unexpired term with a member who meets the qualifications of Paragraph 62.

Qualifications

Bylaw Qualifications

Par. 62: All candidates for Director must submit a Declaration for Candidacy & Resume Form for Director and comply with the following qualifications:

- (a) A citizen of the United States of America.
- (b) A member of the GCU for a minimum of five (5) years as of January 1 of the election year.
- (c) A person of Slav origin and a Byzantine Catholic for a minimum of five (5) years as of January 1 of the election year.
- (d) Of good moral character, reputation and good American spirit.
- (e) A candidate must have attained the age of 30 prior to January 1 of the election year and not be older than age 77 prior to January 1 of the election year.
- (f) Any other qualifications set forth by the Directors in the Declaration of Candidacy & Resume Form for Director.

Qualifications as set forth by the Board of Directors per Par. 62 (f) are as follows:

Must possess a minimum of two of the following:

- ❖ Bachelor's degree or higher.
- ❖ Currently hold or has held a senior level, Executive or C-Suite position for a minimum of five years.
- ❖ Own a successful business for a minimum of five years.
- ❖ Currently employed or has been employed in the financial/insurance industry for minimum of five years or possess a financial/insurance certificate for a minimum of five years.
- ❖ Serve or has served on a professional Board for a minimum of three years.

Qualified candidates must submit their Declaration for Candidacy by January 31, 2023. Declaration of Candidacy forms are available on the GCU website in the Member Events section or can be obtained by calling GCU President/CEO George Juba at 724-495-3400 ext. 3928 or emailing gjuba@GCUusa.com.

Summary of Directors' Responsibilities

As a member of the GCU Board of Directors, a Director is responsible for the effective governance of the GCU. Their main purpose is to advise, govern, set and oversee policy & direction, and assist with the leadership and general promotion of the GCU in support of its mission, strategic vision and core values.

Expectations of Board Members

As a member of the GCU Board of Directors, a Director is responsible for the effective governance of the GCU. Their main purpose is to advise, govern, set and oversee policy & direction, and assist with the leadership and general promotion of the GCU in support of its mission, strategic vision and core values.

Key Responsibilities

Members of the Board shall share these responsibilities while acting in the best interest of the GCU. Each member is expected to make recommendations based on their profession, experience, expertise and vantage point in the community.

- Organizational leadership and advisement.
- Formulation, oversight and governance of policies and procedures developed by the Board.
- Establish overall long and short term goals, objectives and priorities for the GCU.
- Recommend policy.
- Prepare for and participate in the discussion and the deliberations of the Board.
- Financial oversight, including approval and oversight of the annual operating budget.
- Oversight of program planning and evaluation.
- Monitor and evaluate the effectiveness of the GCU's annual business plan through a regular review of sales and budget reports as well as a review of products, programs, and services as compared to the market and competitive environment.
- Review of key departmental (finance, membership, sales, marketing, fraternal) plans, budgets and performance reports.
- Promotion, and support thereof, of the GCU's membership and mission through advertising, outreach and community networking.

Meeting and Time Commitment

- *The Board of Directors meets quarterly with a minimum commitment of 20-30 days on site annually, not including travel time.*
- In addition, Board members are to be available at the call of the Chairperson of the Board for any special meetings. The special meetings may be either in person or via teleconference.
- Board members are expected to attend GCU events and meetings.

Term

The term of office for these two Board positions will end on September 30, 2024.

Third Quarter 2022 Financials

I hope you have seen the exciting news in GCU being awarded an A- (excellent) financial strength rating from A.M. Best. It is an honor and privilege to achieve this level of financial recognition from both A.M. Best and KBRA, two well-known industry rating organizations. We are very grateful for the strong member loyalty and trust you have in GCU!

Since the first quarter, interest rates have risen to levels we have not seen in many years. The Federal Reserve continues to raise interest rates to tame high levels of inflation. Although the adverse effects of inflation have a drag on our resources, GCU has responded by increasing crediting rates on annuity products thus providing our members some financial relief. Sales activity remain strong with the growth in fixed indexed and deferred annuities.

Highlights of GCU's nine-month results are as follows:

I am pleased to report the financial results for the nine months ended September 30, 2022. Net income in 2022 was \$18.7 million versus \$21.8 million in 2021. Total assets and surplus increased to \$2.6 billion and \$221.4 million, respectively, as of September 30, 2022.

Income before net capital gains (losses) totaled \$18.4 million, \$3.2 million lower than the \$21.6 million reported in 2021. Net realized capital gains were \$281 thousand in 2022 compared to \$148 thousand in 2021. Net income after net realized gains was \$18.7 million in 2022 compared to \$21.8 million in 2021.

Total Assets increased \$202.6 million to \$2.616 billion at September 30th from \$2.414 billion at December 31, 2021. The increase in assets reflect the growth in invested assets from new business sales and portfolio earnings. We continue

to be successful in purchasing investment grade securities at shorter durations, increased credit quality, and at higher yields. We are also committed to building our strategic asset allocation by investing in alternative assets (investments in LLC's and limited partnerships) on a risk-adjusted basis.

Total liabilities grew commensurate with life and annuity sales and totaled \$2.395 billion as of September 30 compared to \$2.205 billion at year-end 2021. The \$190 million increase in total liabilities is due primarily to a \$193 million increase in life and annuity reserves, a \$7.8 million increase in unsettled security trades, reduced by a \$5.8 decrease in AVR, and a \$5.2 million decrease in the IMR from deferred investment gains/losses.

Total Income increased \$73.6 million in the first three quarters of 2022 to \$392.6 million from \$319 million in 2021. Life sales increased 27% from growth in our whole life single premium product. Annuity sales and exchanges increased \$70.1 million to \$294.2 million in 2022. Net investment income of \$87.0 million increased \$3.4 million from higher assets under management and income earned on bond prepayments.

Operating expenses, before the increase in reserves, totaled \$180.3 million versus \$171.4 million in 2021, an increase of \$8.9 million or 5.2%. The increase in agent commissions from higher sales were largely off-set by lower exchanges of annuity contracts. General insurance expenses were \$119 thousand higher when compared to 2021.

The increase in policyholder reserves totaled \$193.7 million compared to \$125.8 million in 2021. Reserve changes are primarily a function of premiums received, death and annuity benefits paid out, and interest accumulation. Growth in reserves primarily reflect the increase in sales of fixed indexed and flexible premium deferred annuities.

Surplus grew to \$221.4 million as of September 30th

compared to \$209.2 million at year-end 2021. The \$12.2 million increase in surplus is attributable to the additions of \$18.7 million of net income and the \$5.8 million change in AVR reduced by the change in unrealized gains (loss) of (\$11.4 million), (\$0.3 million) increase in non-admitted software development costs; and (\$0.6 million) reduction for GCU Holding Company's net loss.

Total Adjusted Capital (TAC) was \$239.6 million as of September 30, 2022. TAC starts with surplus of \$221.4

million and adds back the asset valuation reserve of \$18.0 million and one-half the dividend liability of \$150,000. TAC is a financial strength measure closely monitored by rating agencies. The solvency ratios based on TAC were 110.1% and 110.7%, as of September 30, 2022 and December 31, 2021, respectively. These ratios reflect the consistency of GCU's excellent financial strength.

Christmas is Not a Date It Is a State of Mind

In a few weeks we will be celebrating the Nativity of our Lord, God, and Savior Jesus Christ – Christmas. Most of the Christian world will celebrate this great Feast on December 25, or those on the Julian Calendar on January 7. However, many religious historians will quickly tell you the actual birth date of Jesus Christ is unknown. Some biblical scholars believe Jesus’ birth would have occurred during April-October, while some historical documents claim birth dates as precise as March 28. Latin-speaking Christians had come to the view that December 25 was the “historical” date of Christ’s birth before the end of the Third Century.

The Roman Emperor Aurelian (270-275) instituted a new pagan festival, the Birth of the Unconquered Sun, on December 25, which was then the Winter Solstice. Consequently, December 25 was popularized as the date for Christmas, not because Christ was born on that day, but because it was already popular in pagan religious celebrations as the birthday of the Sun. In any event, in A.D. 350 Pope Julius I, bishop of Rome, is recognized by historians as having proclaimed December 25 the official celebration date for the birthday of Jesus.

The East took January 6 as the date to celebrate the “manifestation” of Christ, his birth, his manifestation to the Magi and especially his baptism in the Jordan, hence Epiphany or Theophany. In the Fourth Century the celebration of December 25 as the commemoration of Christ’s birth began to spread in the East.

The actual year of the birth of Jesus is an unknown, with most accounts placing it somewhere around 5 B.C. The “Star of Bethlehem” is cited in scripture as heralding Jesus’ arrival, and is believed by some to be a slow-moving comet documented by Chinese astrologers also in 5 B.C.

“Christmas is not a date—it is a state of mind.” What is important is not the exact day of the birth of our Lord, but that Christmas is the experience of the Eternal God, through

Jesus Christ. By the Incarnation of the Son of God, our generosity and joy become standards in Christian living where grief and sadness do not exist. Jesus is coming with a new promise of love, which is in the Christian heart and does not leave, because Christ Himself wipes away all anxieties.

There are times when we think about the Nativity season, that we tend to lose the real meaning behind the spectacular decorations, music, etc. These external trappings are important for our lives as well – for our physical and emotional

well-being. But how about our spiritual side?

Our spiritual preparation often takes a back seat to our material preparation. We are all called to live this divine event—this Incarnation—this God with Us! We are called to awaken this reality of “God with Us” in others by our own reality of the “God with Us” experience. Each day as we prepare to celebrate the Nativity of our Lord, we have many opportunities to share in this Holy Season.

Let us show the world the real meaning of the celebration of the Nativity of our Lord, and not the hype. Stress the message of Christmas (Love), not the materialism! Lessons in the Law

Estate Planning Requires the Correct Attorney

A good friend from college who lives in another state called me about his father. His father had taken ill and was going to undergo surgery and the doctors were not sure of the success. My friend's father did not have a Power of Attorney for finances and did not have a Living Will and Health Care Power of Attorney. Without these documents in place, his spouse and his son had no authority to make any kind of financial or medical decisions. My friend said he would be in town the next day and I agreed to meet with the family and try to get the documents in place.

What happened next is what happens when an attorney who does not practice in this field gets involved. My friend's mom was talking with her next-door neighbor and said I was coming the next day to get the information to create the necessary documents. The neighbor said he

would get the documents done that day and she would not have to worry and wait until tomorrow. Sounds good, right? The problem, the documents the attorney prepared were not Ohio specific and the financial Power of Attorney he prepared was not durable which means that if you get ill or if you are ill now, the Power of Attorney is not valid.

My friend's dad had a set back the next day and had to have emergency surgery. When I was given the documents to review, I was very nervous that if the dad did not get better, the documents would be useless. Fortunately, he recovered and immediately I prepared and drafted new documents which he executed and now the family had valid documents.

The lesson learned here is that not all attorneys know the rules in areas they do not practice in. Make sure you are dealing with an experienced attorney in the estate planning area.



Come and See 2022 a Strong Sign of Hope

For many years I have been discerning the Holy Priesthood. But only recently, in my senior year of high school in 2020, did I take my faith and discernment seriously. Last year (2021), my spiritual father, V. Rev Jim Koury, informed me about a three-day weekend retreat for discerning Byzantine Catholic men. It's held once-a-year in November at the Byzantine Catholic Seminary of Saints Cyril and Methodius in Pittsburgh, and I was eligible. I applied and was accepted to participate. I attended it with the closed mindset of "I don't think the Seminary is for me." By the end of the retreat, I had many questions for myself. These questions arose because I felt it had refueled the small fire urging me to take discernment to the Holy Priesthood more seriously. The two biggest questions that arose were "am I in the right major in college?" and "When am I ready to join?". I had talked to my spiritual father about my experience going, and I was advised to "Pray about it. There is no rush." I took his advice, and prayer became my journey friend.

I had planned on not attending another "Come and See," thinking I was all set and had the discernment I needed to consider joining the Seminary after college, but Fr. Jim had insisted I go again, saying, "It won't hurt you going again! And you will always learn more!". So, I applied for the 2022 "Come and See" and was accepted again. It took place from the 4th through the 6th of November at the Byzantine Catholic Seminary in Pittsburgh. I was one of 21 young men in attendance. Together we represented the Melkite, Ukrainian, and Ruthenian jurisdictions.

This time I could take in more information than before since I was more familiar with what would happen during the retreat. The first day of the retreat (Friday) focused on learning about the four dimensions of formation (spiritual, intellectual, pastoral, and human). The Seminary's Director of Human Formation explained each dimension's meaning and its key in our lives. At the end of that night I reflected on each dimension and how I could improve myself more in each.

The following day during brunch after Divine Liturgy, I talked with my mentor about the four dimensions of formation. He told me, "A big part of Seminary is that not only will your professors/mentors help you grow, but also your peers." Following brunch that day were talks on a week in the life of a seminarian, the challenges of discernment, the Theology of Priesthood, and discerning marriage and priesthood. Each talk helped me understand how to prepare myself if I am accepted as a seminarian and what to look for during my discernment journey.

My favorite part of Saturday was the panel discussion. This allows time for the retreatants to ask the seminarians any question they want ranging from their pre-Seminary studies to their favorite books and saints.

On the last day of the retreat (Sunday), we began the day with early-morning Matins in the Seminary Chapel followed by Divine Liturgy at a nearby parish. For the conclusion of the retreat, the rector explained the discernment journey, and from what he said, I learned it is not me who chooses whether to become a Priest or not, but God.

As my time began to end at the retreat, I had set three goals for myself by the time I graduate from college: First, take elective classes to help me think like a philosopher/theologian. Second, increase the time dedicated to God each day, like in Seminary. Lastly, work on approaching new things with an open mind.

My thoughts on the "Come and See" retreat are that it gave me hope and a plan about my future, and that I encourage young men who take their Eastern Catholic faith seriously to take advantage of this opportunity in the future.
